
Trixie the rabbit recently asked a question about our post boxes and a week later a box was hit and damaged. We don't know who or what hit it. The USPS was notified immediately and they did take pictures. We do know that all of our Cluster Box Units are **at end of life**.

Brief history for those that do not know. The assistant post master attended a meeting at Briarpatch he had been misled regarding Briarpatch's **needs and desires** regarding cluster box replacement. He was subsequently badgered out of the meeting by the audience and our attorney of the time. It wasn't pretty! He had presented to our representative at the time that 55+ communities were **obligated** to install a single **C**luster **B**ox Unit (CBU) holding 194 letter boxes and parcel boxes. They wanted to install it by **taking** parking spots near the pool and of course it was rejected by the community. In our communications with them since, they have continued to stick to their proposal or not communicate at all. The rule they speak of applies directly to **Newly built** 55+ communities. We are, allowed to repair and replace the current CBUs under their rules.


In February I sent a letter to the District PM in Tampa and did not hear back. However, David was able to reach the local Postmaster, who now was very amenable to meet. David, myself and the PM and Asst.PM met on 4/17/25. After our meeting the PM was going to verify what can and cannot be done. We are currently researching CBU sales and installation companies. 

Dear Homeowners, please be sure to notify any contractor working on your home's Cable— Spectrum & Frontier, HVAC—a/c system or electrical system that NO wires or cable are allowed on top of the roof or outside of the building.

Please follow the Speed limit when driving through the neighborhood. **15 MPH**

Those who have **screens in disrepair MUST** have them Repaired or Removed. **Please walk out back and look at your screens!**

We have started the re-roofing program on April 28, 2025. I ask that homeowners take pictures of the inside of their home, with dates before the work begins. We will be re-roofing buildings 13, 14, 15, 16, 17, 18 and 19 on Remus.

Buildings 31—36 are due to be painted this year, date TBD.

Our siding replacement and repair program, will begin in a few weeks. We will complete the most needed repairs that we can within budget. Remove, Wrap, Replace Siding.

WHY MUST THE POOL GATES REMAIN SECURELY LOCKED?

The pool has the inherent danger of someone drowning. The gates must be kept locked to prevent children from entering the pool area.

Our liability insurance dictates that the gates be locked at all times. If we do not follow their mandate they will pull the insurance coverage. We cannot operate the **pool without liability coverage**. The insurer performs routine random inspections. On the last inspection the gate was left ajar. We were threatened with cancellation of insurance and pool shutdown. The gate hinges have been replaced ensuring the gate will self close.

PLEASE MAKE SURE TO CLOSE THE GATE BEHIND YOUR SELF AND MAKE SURE OTHER DO SO AS WELL!

Bylaw Review

13. The owner of each lot shall keep the grounds **free of all refuse and equipment**.

Signs shall not be permitted on Lots, with the following exceptions:

- a. Owners who are selling their property may install a <u>"For Sale" sign not to exceed 24</u>"
 <u>by 24</u>". This sign must be professionally printed "For Sale by Owner" or represent a Real Estate Firm. This sign shall be placed directly in front of the garage wall under the outdoor light, or in the garden near the front porch of the home. No sign posts or other signage is allowed.
- b. Lot owners who have a paved parking pad on their property may post a private parking sign in front of the paved parking pad; the only private parking signs allowed are the standard signs supplied by the Association.

c. Security service signs shall be permitted where owners have security systems. Signs not to exceed one square foot.

d. Signs shall be maintained by the homeowner in a clean, undamaged condition.

This month as planned, we will stay close to home in our beautiful quaint little town of New Port Richey. The town was given the nickname "Hollywood of the East because in the past (especially in the 20's) it was a place visited by film stars who stayed at the now newly renovated and historic Hacienda Hotel. Famous people such as Johnny Cash and Irvin Berlin lived in New Port Richey. JohnnyCash's home is still on the Cotee River

There is a lovely and serene community nestled inside the borders of New Port Richey. The community was constructed between 1986 to 1993. As for the name of this community, Professor Bryan Wagner says that name came from a story of a fox who traps a rabbit making it get stuck to a figure with tar poured on it. The rabbit outsmarts the fox by asking not to be thrown into a certain place but that is where he really wanted to go. That was his hope. So, the rabbit won and got out of a challenging situation. You guessed!! It is the Briar Patch, our home.



Wagner says, "The Briar Patch is a symbol of the commons, the...land that provides refuge and resources that sustain the life of the community."

One famous singer with a family tie to new Port Richey is Whitney Houston. She sang a song that is in harmony with Wagner's description of Briar Patch. Fun Facts About New Port Richey: The modern sand wedge for golfers was invented in New Port Richey. / New Port Richey was the first city in the area to make a provision for community services. / New Port Richey is the home of Chasco Fiesta which is a celebration honoring Native American Tribes. / The sponge industry near New Port Richey in Tarpon Springs made that area the sponge capital of the world. / The Cotee River is an abbreviation for Pithlachascotee. / New Port Richey is the burial ground for two different Indian tribes.

CABLE vs. FIBER

This information is here to make sure everyone knows and understands a bit about how you receive internet and tv service. F.Y.I. our community like every other HOA community is being asked by Fiber optic and cable companies to change services. <u>You need to know because YOU will</u> <u>be advising the BOD on what changes if any we will take in the future.</u>

What is cable and what is fiber? Most of us have cable to and internet services. The electronic or digital signals are sent from the cable/internet service provider (ISP) to our homes. The signal travels through Ethernet cables or it may travel through a Fiber optic cable. What is the difference?

We normally see "cat" 6 – 9 coaxial cable, these cables consists of an **inner copper wire** cover with insulation and another shielding. It has a plastic layer that offers insulation between the braided metal shield and center conductor. Coaxial cabling has a single copper conductor in its center. **This is what we all have in our homes at present.**

Fiber optic cables mostly consist of a **center glass**, and different layers of protective materials surround it. **Fiber-optic cabling transmits light** in place of electronic signals, which removes the issue of electrical interference. This makes it an ideal selection for environments that contain a large amount of electrical interference. This type of network cable offers an ability to transmit signals over longer distances. It also provides the ability to carry more information at faster speeds.

Pros: Fiber is faster and carries much more information at higher speeds. Fiber can handle the increasing amount and size of digital material. Cable is already in the ground.

Cons: Cable is limited and cannot carry increased size of digital information transmitted. It slows down and has drop offs of information etc. The speed of transmission is slower. A fiber optic network would need to be installed, they do it for free.

The cable companies are willing to pay communities like ours to stay with them and not switch. They offer deals like stay with spectrum for 10 years we will pay you \$70,000.00. The Fiber companies offer deals by installing the fiber network for Free and capping costs for service to the consumer for 10 years. We will evaluate offers from different companies to discern what would work best for ALL OF US in Briarpatch. The information will be presented to everyone for review.
